STATEWIDE SYMPOSIUM ON Child Well-Being in Pennsylvania and the Urgent Need for Father Involvement

SEPTEMBER 27, 2017

In America, we like to think that in the best set of circumstances most children are raised by their biological parents in a healthy, supportive environment, and never experience disruption of their parents' emotional, social, physical, intellectual, spiritual or financial support. However, the U.S. Census Bureau Reports that 31% of our children are living with either a single parent or no parent at all (23% with mother, 4% with father, and 4% with no parent). The Annie E. Casey Foundation Kids Count Data Center show that nearly 25 million (24,444,000) or 35% of American children lived in single parent families. In Pennsylvania the number is 914,000 or 36% of the child population. The National Fatherhood Initiative (NFI) declares that the incidence of the impact of both parents not being "present" in the lives of their children, most often fathers, is a contributing factor to the number of children in the child welfare and juvenile justice systems of care. Children with involved Fathers, on the other hand, often experience just the opposite. They are more likely to better perform across every measure of child well-being than their peers in father-absent homes. NFI believes "father-absence" is a major impediment to the well-being of children and families in America, Pennsylvania is no exception. We come together to explore this issue.
